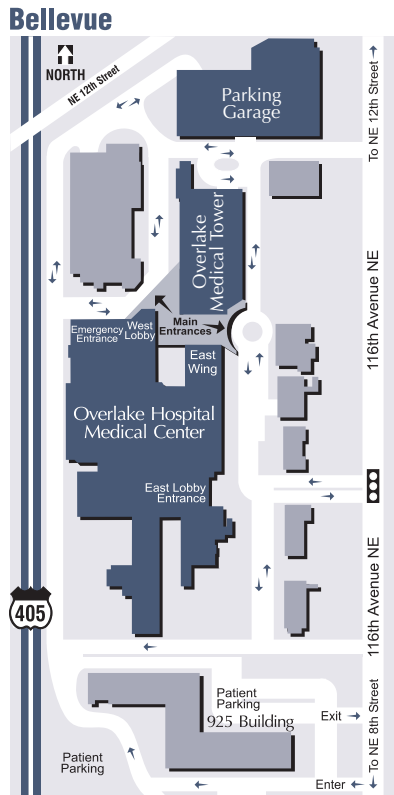
### How to find us in Bellevue:

#### SOUTHBOUND

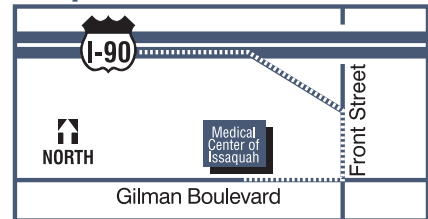

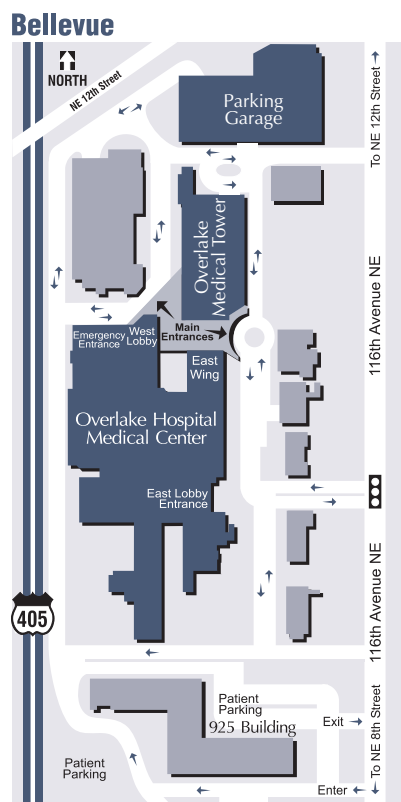

##### **SOUTHBOUND**

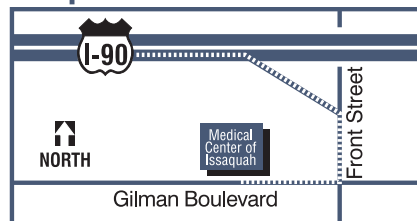
Exit I-405 at NE 8th St.
